## Terms

- A deposit of 50% of full package price that you have chosen must be submitted with both pages of this form no later than **April 7<sup>th</sup>, 2006**. The full payment is due no later than **Friday April 14<sup>th</sup>, 2006**. Payments can be made by case, check, Visa, Mastercard, Discover, or American Express. There will be a \$30 charge for any returned checks.
- Vendor set up starts at **9:00 am Sunday morning on April 23rd, 2006**. Pre-show registration starts at **12:30pm**. There will be a fashion show at **2:30pm**.
- All presentations, demonstrations, and other activities or functions will take place in the main stage area.
- Vendors/exhibitors must bring their own extension cords, duct tape and other electronic accessories or equipment. Positive Vibes will not provide these accessories.
- **There is no unauthorized sharing or subletting of exhibit space allowed.** Only the vendors or exhibitors specified on the form may occupy booth space according to the package chosen by vendor/exhibitor. There can also be no materials of any kind promoting another business to be handed out before, during, or after the show. Any vendor/exhibitor who violates this part of the agreement will pay \$65 per unapproved business that they promote.
- **Authorized subletting** is permitted with the purchase of a co-promotion package per subletting company individual. Authorized subletting is also permitted for companies purchasing a Sponsoring Business booth. The main company completing this agreement is obliged to provide contact information for subletting companies. Authorized and non-authorized Subletting companies will not receive website listings.
- Positive Vibes Inc. reserves to right re-assign space according to the package chosen by vendor/exhibitor.
- Exhibitors that wish to sell products on site during this event must obtain vending license from City of Norfolk Virginia. Contact the City of Norfolk Department of Business Licenses for further information.
- Positive Vibes Inc. shall not be responsible for any damages or additional expenses incurred by vendor/exhibitor in connection with the show.
- This show may be videotaped and photographed by a company hired by Positive Vibes Inc. By signing this agreement, the above named company consents to the use of faces, names, likeness, trade-name and trademark of the company and its representatives in such photos and film for use on our websites and future promotions.
- Positive Vibes Inc. reserves the right to deny any applications for whatever reasons our company chooses.
- Once accepted, this contract is non-cancelable. Refunds will only be made if application is not accepted. By signing this agreement, the vendor/exhibitor, their employees and representatives, agree to comply with all policies (both stated and inferred) and rules of Positive Vibes Inc. and the hosting facility.
